PW ACCEPTABLE USE POLICY

The SCDOT PW system provides a secure method in which to allow remote users access to project files and information via the World Wide Web. The integrity of the organization's data is of prime importance. The following terms and conditions protect SCDOT's information and communications from unauthorized access, in accordance with the SCDOT's security rules and policies.

Acknowledgment, acceptance, and adherence to these items will predicate the issuance of your account.

Terms and Conditions:

- Users must use the SCDOT PW system in a responsible, lawful, and ethical manner. Usage for personal or unauthorized activities is strictly prohibited and could result in criminal prosecution under applicable state and federal laws. Users must use the SCDOT PW system solely to serve SCDOT's mission and goals.
- Users should not expect privacy, rights, or ownership in anything accessed, created, stored, sent, or received within SCDOT's network. This signed application constitutes your waiver and consents to monitoring, retrieval, and disclosing any information within the SCDOT network for all purposes deemed appropriate to enforce SCDOT's security rules and policies.
- Be aware that the SCDOT creates an audit log detailing every inbound and outbound connection made to the network. User account activities are recorded by the PW audit trail to include creating an account and the user's login and logout history. The audit history consists of any action performed with files or folders within the PW system.
- The SCDOT PW Coordinator assigns unique usernames and passwords for each user. Users are required to change their password upon receipt of account information. Users may not share their password with any other individual. Passwords must be a minimum of 8 characters long. Passwords must contain at least one upper and lower case character (e.g., A-A, a-z). Passwords must contain at least one number and one special character (e.g., 0-9, #\$%^&*()_+=\|~`[]{};:/?<>,.).
- Consultant or contractors should be aware that any individual who is no longer an employee of their firm will have access to the SCDOT PW system until a request is submitted to the SCDOT PW Support Team to disable the user's account.
- Users are responsible for securing sensitive personnel and financial or security-related information they are authorized to handle.
- Accessing, viewing, downloading, or storing pornography within the SCDOT PW system is strictly prohibited. Transmission of
 material in violation of any state or federal law or regulation is prohibited.
- Transmission of material in violation of any state or federal law or regulation is prohibited.
- Dissemination of information regarding SCDOTs network, network topology, network address(es), or hardware is prohibited.
- Unauthorized activities that could compromise SCDOT's systems or data are strictly prohibited, including network scanning (sniffing), vulnerability scanning, security testing, and password cracking.
- Attempts to defeat security mechanisms are treated as a security incident and are potentially subject to civil and criminal
 penalties. Users should report any observed attempts by others to defeat security mechanisms to the SCDOT.
- Users are responsible for maintaining full and up-to-date virus protection on any device used to access the SCDOT PW system. All downloaded files must be isolated and checked for known viruses before use.
- The reliability of Internet access and Internet email depends on the configuration and availability of systems beyond SCDOT's network. Therefore, problems affecting these services may be outside the control of the SCDOT.
