Revision	In seciton 2.2.7, the professional services goal will be changed to .3%.

Some services provided on the construction side of the project require registered professional engineers review and sealed. Would professional type services in support of the contractor count toward the 0.8% DBE goal for professional services and if so, can you clarify which ones will count?	Revision	In section 2.2.7, revised link in this section to the document that defines professional services for SCDOT. Given the duration of larger, relevant construction Projects that are frequently completed several years after award, will the Department consider extending the timeframe of "project award" to twelve years, or changing the requirement from "awarded" to "completed" in the last ten years so teams can provide the most relevant projects?		In section 3.5.1, a revision will be made to allow the last 12 years.

No_Revision	This is from Contract Execution to Contract Closeout. This is the full length of the Contract.
16		3.4.4	page 12 of 27	RFQ states Project Manager is to be on site during all construction activities.  Please define what constitutes the "start of construction activities". For example, Is the PM required to be on site during mobilization activities?  During MOT set up? or just when physical demolition and/or construction is taking place?	No_Revision	It actually says be available to be on-site during construction activites. If they need to be there for whatever reason they need to be able to be onsite. If we needed them on-site during one of the activities mentioned, we expect them to be available.
17		3.4.6	page 13 of 27	RFQ states Construction Manager is to be dedicated solely for the duration of construction and on site during all construction activities. Please define what constitutes the "start of construction" where the CM will be expected to be on site.	No_Revision	Start of construction is when any construction activities begin. For instance, if you request to begin early construction activites, like clearing, that would be your start of construction. If you begin after RFC plans are complete then that would be your start of construction. They would be expected to be there through completion of construction items.
18		2.7	5	Considering the Memorial Day holiday, would SCDOT consider an extension of the SOQ due date by 1 week?	No_Revision	The due date will stay the same as in the Milestone Schedule.

No Povision	It counts as one of the 10 pages regardless of the size.
22	5.2	21, 22	The SOQ page containing the organizational chart, should this page be dedicated solely to the organizational chart only?	Revision	In section 5.2.5, the language is revised to state that the page with the org. chart shall only have items specifed in bullet one of section 3.3.1.
23	2.2.7	3	Given the significant structure scope limiting opportunities during construction for DBE participation and recent difficulty in achieving the DBE goals on similar projects, would the Department consider reducing the 12.8% DBE goal?	Revision	The goal is being revised to 12.3% but that reduction is only in the professional servcies section.
