

We want to let you know about two of the flood damaged locations that are being repaired using design build contracts. They are SC 48 (Bluff Road) over Toms Creek and SC 769 over Cedar Creek. Google placemarks are attached for your use. We plan to install bridges in these two locations. We noticed that there was a SCANA communications line along SC 769, but we are uncertain about the other location.

This is an expedited design build procurement so the contractor teams may be seeking information later today through next week. Our proposed schedule is to execute a contract on the week of November 2 with the contract completion being in April.
