





Anticipated Scope of Work

- Demo existing bridges
- Build new bridge structures
- Construct roadway approaches for new structures.

Design Criteria Changes (PCDM-11)

- Preconstruction Design Memorandum – 11, Low Volume Criteria updated recently in 2026 to Low Impact Criteria. 5 additional sites qualified for Low Impact Criteria.
- Prep plans previously developed do not reflect changes in criteria (next slide)
- Sites shown as off-alignment may be reconsidered for close & detour (pending final public involvement activities)

Roadway

- 10 Sites to be designed using full criteria
- 8 Sites to be designed using Low Impact Criteria
- Sites are located on all roadway classification types.
- Design speeds range from 30 mph to 60 mph.
- 5 of the 18 sites require bike accommodations S-21-29, S-16-179/S-21-356, and all 3 sites on S-8-791.
- Low potential for DE's or Criteria Variance

Structures

- The 8 sites that qualify for Low Impact Criteria are anticipated to be SCDOT standard cored slab / box beam bridge type. Detailed seismic analysis is not required.
- The 10 sites designed with full criteria are anticipated to be flat slabs and/or prestressed concrete beam bridges. Detailed seismic analysis is anticipated for all bridges (except for single spans) in this package with ADT > 3000.
- Minimum bridge lengths will be specified at all sites based on preliminary hydraulic modelling information.

Hydro

- Conceptual hydraulic memos and models will be provided.
- Package 22 has different levels of design difficulty which may create the need for design variances.
- Low Impact Criteria for qualifying bridge sites will aid in some design difficulty.
- All sites should meet a finding of “no impact”.
- Some bridge sites will require site specific prescribed criteria in Exhibit 4e of the RFP.

Environmental

- PCEs will be provided to teams
- GPs anticipated for all sites
- Teams responsible for permitting and any required mitigation
 - Exception: SCDOT will cover cost of mitigation for S-30 over Black River
- NWP 3 allowable option
- State Navigable Waters Permit needed for:
 - S-19 over Indian Fields, S-30 over Black River, S-41 over Ashepoo River, and S-356 over High Hill

Environmental

- S-30 over Black River: 4f resource adjacent to bridge, known cultural site
- NLEB Clearing and Pile-Driving Restrictions:
 - S-41 over Ashepoo: Dec 15 – Feb 15 and April 1 – July 15
 - S-791 over Molly Branch: Dec 15 – Feb 15 and May 1 – July 15
- NLEB Light Minimization and Clearing, Demo, and Pile-Driving Restrictions:
 - S-19 over Indian Fields Swamp: Dec 15 – Feb 15 and May 1 – July 15
- Potential Phase II ESA Commitments for S-29 over Jeffries and S-32 over Reedy – Will be confirmed by Final RFP


