

Request for Best and Final Offer **Revision 1**

Emergency Bridge Package 2018-2B

The South Carolina Department of Transportation (SCDOT) has completed an evaluation of proposals, deemed the selected Proposers responsive, and conducted confidential “discussions”. SCDOT requests that Proposers revise their proposals, if necessary, to reflect the revisions outlined in Addendum 2 **and 3** of the Final Request for Proposals (RFP) and submit a Best and Final Offer (BAFO) Technical Proposal and Cost Proposal.

Proposers submitting a BAFO Technical Proposal shall not re-submit any documents which are unchanged from their initial Technical Proposals. Proposers shall provide necessary changes to individual paragraphs in the narrative, as briefly as possible, together with a table of contents, which clarifies where within the initial proposal changes have been made and where all additional information has been placed. Changes to the narrative shall be highlighted in yellow. Revised plan sheets shall be provided by the Proposers only for those plan sheets which have been changed. Each revised sheet shall contain a note clearly indicating the sheet has been “Revised for BAFO”.

Technical Proposal revisions made by the Proposers will be evaluated based on the procurement process in Section 5 in Addendum 2 **and 3** of the Final RFP.

Proposers shall revise, if necessary, and resubmit a BAFO Cost Proposal, and SCDOT will analyze the BAFO Cost Proposals as outlined in Section 5.6 in Addendum 2 **and 3** of the Final RFP. A new bid bond shall be submitted only if the final revisions to the Proposer’s BAFO Cost Proposal are greater than its initial Cost Proposal.

Technical and Cost Proposal revisions shall include a BAFO Acknowledgement Form that acknowledges receiving all RFP addenda. The BAFO Acknowledgement Form shall be submitted with the BAFO Technical Proposal. If only a BAFO Cost Proposal will be submitted, the BAFO Acknowledgement Form shall be provided with the Cost Proposal.

SCDOT reserves the right to conduct additional Clarifications and Communications after submission of the BAFO. If Proposers do not submit a BAFO Technical Proposal and/or Cost Proposal as outlined herein, the proposer will be deemed non-responsive.



BAFOs must be received by the SCDOT in accordance with the revised Milestone Schedule included herein. The offeror is responsible for ensuring that the BAFO is received by the deadline(s).
