1. Call to Order

Chairman Johnson called the March 20, 2025 Commission meeting to order at 9:00 a.m. He recognized the two new Commissioners, Mr. Sel Hemingway, Jr. who represents the 7th Congressional District and Dr. Britt Blackwell who has filled the Governor's At-Large position.

2. Roll Call

Chairman Johnson called the roll of the Commissioners and declared that a quorum was present.

6. 1 January 31, 2025 Commission Meeting Minutes

Chairman Johnson noted Commissioner Blackwell's decision to abstain from approving the January minutes, since he was not a Commissioner at the last meeting.

Second by: Vice Chair Dukes

The Commission approved the January 31, 2025 meeting minutes.

6.2 Audit Committee Update

Chairman Johnson announced, Pursuant to Article 6 of the Commission Bylaws, his appointment of Commissioner Spencer to serve as Chair of the Commission Audit Committee. He also appointed Commissioner Hemingway and Commissioner Blackwell as members of that committee.

7. Public Comment

Secretary Powell stated there were no public comments.

8. Secretary of Transportation Report

8.1 Secretary of Transportation Report

Secretary Powell congratulated the new Commissioners. He also expressed his gratitude to the Commission on his first year of service as Secretary, which took place on April 1, 2024. He also thanked the SCDOT Team/staff for their support and noted the eventful year (3 major groundbreakings, completion of major interstate projects, and multiple disasters). He recognized the LEAD participants in attendance at the meeting. He began the Secretary of Transportation Report reporting that this calendar year through March 11, 2025, there have been 122 traffic fatalities; we are down 31 fatalities at the same point in 2024. Of the vulnerable road users, there were 26 pedestrian fatalities (up 1 from last year), 2 bicycle fatalities, and 1 moped fatality. We continue to look at ways to bring down these numbers.

SCDOT continues to increase its Work Program. The current active construction program is at \$6.5 billion under contract. Last year at this time, we were at \$5.8 billion under way, increasing the contract values across the state by 12%. These construction projects are consistent with the priorities of the Ten-Year Plan. We have been very active over the last year.

He reviewed the On-Time and On-Budget numbers for the Construction Program: 79% of the projects were on-time and 21% had penalties assessed for not being on-time. The agency was tracking at 1.8% below the original bid.

There were a series of change orders totaling approximately \$13.57 million in Change Orders greater than \$250,000 associated with approximately \$6.5 billion in active contracts for January 1 through February 28, 2025. There were 9 projects with change orders that were discussed: 2 projects were

Design-Build, 1 project related to field conditions, 3 varied issues, and 3 projects due to damage from Hurricane Helene.

Commissioner Blackwell asked if the I-95 (MM 68-84) Rehab project in Dorchester was Design-Build. Secretary Powell responded that it was a Bid-Build project. Commissioner Fishburne clarified that if "Design-Build" was not noted in the project title, then it would be a Bid-Build. Commissioner Fishburne also noted that the US 17(A) project was also on the January Change order list. Deputy Perry responded that this was a second change order since the engineering record had a bust on the borrow excavation. All the dates are correct.

Secretary Powell reported he authorized one emergency procurement on College Park Road, which was due to an impact that occurred on February 6, 2025.

Secretary Powell reviewed the 10-Year Plan Accomplishments and reported that:

- RURAL ROAD SAFETY: 1142 miles have been addressed in the Rural Road Safety Program (RRSP) with a target of 1300 miles. Since the January Commission meeting, there have been an additional 16-miles of sent to contract.
- PAVING: More than 9,620 miles of paving have been addressed in every county of the state.
- <u>BRIDGES</u>: 394 bridges have advanced to construction with a target of 530-bridges. Since the January meeting, we have 24 additional bridges underway and have completed 10 bridges.
- INTERSTATE: Approximately, 111 interstate miles have advanced to construction across all of South Carolina. Construction is underway on the I-26/I-95 Design-Build project with the overpass in Bowman, they are out of the design phase and construction is visibly underway with the flyovers.

In the past year, we have added 154 miles of Rural Road Safety Projects, 1,400 miles of Paving projects, 56 Bridges, and 2 additional miles of Interstate Widening Projects.

He reviewed the New Gas Tax Trust Fund as of January 31, 2025. He stated \$4.7 billion of revenue had been generated since July 1, 2017, and \$213 million had been transferred to the CTCs and the Department of Revenue based on statutory requirements, leaving \$4.5 billion available for road projects. Secretary Powell also reported the New Gas Tax Trust Fund was investing almost \$4.3 billion in pavements, \$349 million in rural road safety, \$293 million in interstate widenings, \$86 million in additional bridge projects, and \$121 million committed to Hurricane Helene Clean-up. The debris clean up in South Carolina is the equivalent to filling the Empire State Building three and a half times – the largest debris cleanup in nearly 40-years.

There were 6 surplus properties conveyed since the January 2025 Commission meeting, totaling \$25,000 in property sales.

He finished the report with accomplishments, to include the Cannons Campground Road Bridge, Scout Groundbreaking, and the College Park Road Bridge.

8.2 Legislative Update

Legislative Director Ted Creech presented the Legislative Update on the budget bills and transportation-related bills. Last week, The SC House passed its version of the FY2025-2026 State Budget. The House budget provides funding for bridges, Hurricane Helene funding, road safety enhancements, and some reoccurring revenue for state matching funds and off-interstate litter pick-up. The Senate is scheduled to vote on the budget package the week of April 20, 2025. The Governmental Affairs team is tracking about 120 bills through the General Assembly.

9. New Business (Action Required)

9.1 Approval of the Multimodal Transportation Plan

Motion by: Vice Chair Dukes

Second by: Commissioner Metcalf

Deputy Secretary Quattlebaum presented Momentum 2050, the new Multimodal Transportation Plan (MTP). She acknowledged LaToya Grate-Adams, Susan Johnson, and Machael Peterson for their work on the plan. The Commissioners were provided a hard copy of the plan. She mentioned the stakeholder meeting and a public survey, which indicated that congestion was the major concern. There are also emerging trends (growing ports, changing demographics, and changing in technology) that could affect the infrastructure. The Plan outlaid current spending and future needs in 13 major categories. SCDOT is investing \$2.2 billion, however, the future annual needs are \$3.2 billion, indicating a gap of \$971 million or a 30% gap in funding that will need to be identified.

Deputies Quattlebaum and Necker responded to a question from Commissioner Fishburne regarding the rail component in regards to the projections of the Port in Charleston. Deputy Perry also mentioned the Navy Base Intermodal Freight Facility that will extend CSX and Norfolk Southern lines. Secretary Powell added that the Palmetto Rail (Dept. of Commerce) is actively building a new rail line in Berkeley County.

Vice Chairman Dukes made the following motion: I make the following motion that in accordance with South Carolina Code, SECTION 57-1-370 (A), the Commission approves the adoption of **MOMEMENTUM 2050**, the Statewide Multimodal Transportation Plan. The plan is to be open for 30-days of public comment with any substantive comments to be provided to the Commission for its consideration.

The Commission approved the Multimodal Plan, Momentum 2050.

9.2 Revision of the 2024-2033 STIP

Motion by: Vice Chair Dukes

Second by: Commissioner Christopher

Deputy Secretary Quattlebaum requested the Commission's approval for the Revision of the 2024-2033 Statewide Transportation to include twelve (12) new projects into the Central Midlands COG System Upgrade Rural Program, four (4) new projects into the COATS MPO System Upgrade Urban Program, and three (3) new projects and removal of one (1) project into the Catawba COG System Upgrade Rural Program.

The Commission approved the request.

9.3 Revision of the 2024-2033 STIP

Motion by: Commissioner Christopher

Second by: Commissioner Fishburne

Deputy Secretary Necker requested the Commission's approval for the Revision of the 2024-2033 Statewide Transportation to include seven (7) Federal Transit Administration (FTA) Large and Small Urbanized Area Mass Transit Projects.

The Commission approved the request.

9.4 Authorizing Resolution for FTA

Deputy Secretary Necker requested Commission Approval for Authorizing Resolution for Federal

Transit Administration. This certification is a new requirement by FTA.

The Commission approved and signed the resolution.

9.5 Changes to the State Highway System

Deputy Secretary McCottry requested Commission approval of the additions, deletions, and revisions of the State Highway System and the authority to convey right of way to appropriate entities. This request includes twenty-one (21) segments of the Secondary Road System resulting in a reduction to the Secondary System of 5.117 centerline miles equating to 10.234 lane miles.

The Commission approved the request.

9.6 Ratification of Extensions

Motion by: Vice Chair Dukes

Second by: Commissioner Christopher

Deputy Secretary Perry requested that the Commission ratify extensions on ten (10) projects totaling

\$5,027,206.67.

The Commission approved the request.

There was no Old Business to discuss.



SC Highway Safety Statistics




2025 Traffic Fatalities







SCDOT has Dramatically Increased its Work Program




SCDOT's \$6.6 Billion Construction Program





10-Year Target: 1300 miles



Road S-523 (Okatie Bluff Road) (f/k/a Road S-81) and Road S-439 (Russ Point Boat Landing) – Beaufort County

Upon request from Beaufort County approval was obtained from the South Carolina Department of Transportation Commission for the formal removal of a portion of S-523 (Okatie Bluff Road) (f/k/a Road S-81) and Road S-439 (Russ Point Boat Landing) from the State Highway System and for conveying the right of way of same on July 21, 1999. Therefore, a gratis quitclaim deed conveying a total of approximately 1.02 miles of road right of way to Beaufort County was executed on March 19, 2025.

The Department acquired right of way for Road S-523 (Okatie Bluff Road) (f/k/a Road S-81) under File Number 7.286 by Deed to Right of Way from J.C. Cheshire dated March 14, 1953 (Tract 6), and by Deed to Right of Way from J.P. Boulware dated March 14, 1953 (Tract 8), and pursuant to Legislative Act 827 of 1948 and action of the Commission dated July 19, 1951, and for Road S-439 (Russ Point Boat Landing) pursuant to Legislative Act 329 of 1951 and action of the Commission dated January 21, 1965.

Road S-1093 (Grandview Drive) - File Number 23.327A - Greenville County

Upon request from an adjacent landowner, a parcel of land along Road S-1093 (Grandview Drive) was determined to be surplus to the Department. The Secretary of Transportation's approval to convey the property was obtained on January 31, 2025. Therefore, a quitclaim deed conveying a total of approximately 0.52 of an acre to Grandview Partners, LLC was executed on April 15, 2025, in consideration of \$10,000.00.

The Department acquired right of way for Road S-1093 (Grandview Drive) under File Number 23.144A by Right of Way Easement from Perry V. and Helen S. Haymes dated January 7, 1987, Tract 4.

Road S-957 (Oliver Street) – File Number 38.408 - Orangeburg County

Upon request from the Town of Bowman approval was obtained from the South Carolina Department of Transportation Commission for both the formal removal of a portion of Road S-957 (Oliver Street) from the State Highway System and for conveying the right of way of same on March 21, 2024. Therefore, a gratis quitclaim deed conveying approximately 0.03 of a mile of road right of way to the Town of Bowman was executed on March 11, 2025.

The Department acquired right of way for Road S-957 (Oliver Street) ursuant to Legislative Act 36 of 1959 and by action of the Commission dated September 17, 1959.

Road S-794 (Bomar Avenue) - Spartanburg County

Upon request from the City of Landrum approval was obtained from the South Carolina Department of Transportation Commission for both the formal removal of a portion of Road S-794 (Bomar Avenue) from the State Highway System and for conveying the right of way of same on December 5, 2024. Therefore, a gratis quitclaim deed conveying a total of approximately 0.03 of a mile of road right of way to the City of Landrum was executed on March 11, 2025.

The Department acquired right of way for Road S-794 (Bomar Avenue) pursuant to Legislative Act 329 of 1951 and by action of the Commission dated June 27, 1968.





Momentum 2050: Statewide Multimodal Transportation Plan

Public Comment Summary

Comment Period: March 20, 2025 – April 19, 2025

On March 20, 2025, the SCDOT Commission approved the adoption of Momentum 2050, the Statewide Multimodal Transportation Plan. In accordance with South Carolina Code, Section 57-1-370 (A), federal law, and public involvement practices, SCDOT requested public comments on the plan for a thirty-day period.

Momentum 2050, received 189 comments, of which 142 were directly pertaining to the plan, during the public comment period. Comments received reflected what survey participants shared last summer which is congestion is a major concern and public transit is desired. Additional feedback focused on preferences for shuttles, passenger rail, monorail, biking, walking, lane painting for visibility & safety, and ferries. Several people noted the aging population needs additional transportation options as driving becomes more challenging and the cost of rideshare services can be cost prohibitive. Maintenance and better signage were also mentioned. Several comments included requests for tolling roads to improve congestion.

No substantive comments were received that would impact the draft plan presented on March 20, 2025. Everyone that provided a comment will receive a response from SCDOT.

Preservation

Preservation treatments are used on roads in good condition in order to preserve these roads to extend the pavement life at an acceptable level of service. Preservation projects account for a small portion of the annual program budget.

Preventive Maintenance

Preventive Maintenance treatments are used on roads in fair condition in order to maintain and preserve these roads to ensure full pavement life is achieved at an acceptable level of service. These projects are utilized on routes still in fair condition in order to provide a cost effective means of preventing the route from deteriorating to a poor condition where repairs would become more extensive and costly. These include treatments up to 2" mill and replacement of asphalt.






Pavement Treatments Costs per Mile for 2 Lane Highway







County-by-County Allocation

Funding is allocated to counties based on their relative share of lane miles for each system.



Priority Ranking Process

Rehabilitation/Reconstruction treatments are used to make major repairs or fully rebuild roads based on priority ranking among roads in poor pavement condition. The priority rankings are based on relevant criteria and associated weightings including:

- 40% Pavement Quality Index (PQI) is rating of the pavement surface based on distresses.
- 15% International Roughness Index (IRI) is measurement of how bumpy the road feels to the user.
- 15% Average Daily Traffic (ADT) is the average traffic volume per day.
- 10% Average Daily Truck Traffic (ADTT) is the percentage of ADT that is truck traffic.
- 5% Percent Patching is the estimated amount of patching on a road or is in need of for the segment.
- 5% Strategic Corridor Network is used as a supplemental criterion to add emphasis to roads on the strategic corridor network.
- 5% Functional Classification adds emphasis to more significant functional classifications.
- 5% State Safety Programs adds emphasis to road segments that are also included in the safety program.

Removal of Roads on the State Highway Secondary System

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

- 1. Abandonment of section of relocated highway In accordance with Section 57-5-120 of the Code-of-Laws of South Carolina, the department may abandon as a part of the state highway system any section of highway which may be relocated, and every such section so abandoned as a part of the state highway system shall revert to the jurisdiction of the respective appropriate local authorities involved or be abandoned as a public way.
- 2. Highway transfers from the state secondary system In accordance with Section 57-5-80 of the Code-of-Laws of South Carolina, The department may transfer from the state highway secondary system any road under its jurisdiction, determined by the department to be of low traffic importance, to a governmental or non-governmental entity if mutual consent is reached between the department and the party that the road is being transferred to.
- 3. Court ordered closure In accordance with Section 57-9-20 of the Code-of-Laws of South Carolina, an entity may petition the circuit court to have a road closed. The Department is notified of the petition if the road is maintained by the Department, and has an opportunity to contest the petition if the road is of high traffic importance. If the court shall determine that it is in the best interest of all concerned that such street, road or highway be abandoned or closed, the court shall then determine in whom the title thereto shall be vested and issue an appropriate order.

Revision of Description of State Highways

The Department recommends Commission approval of the revision of the description of sections of State Highway previously added to the State Highway System. The description of roads currently in the State Highway System may be changed for relocation purposes, to revise the description of the termini to show what was actually constructed by contract, county line changes, or a change in the road number.

Additions to State Highway Secondary System

The Department recommends Commission approval to add sections of road to the State Highway Secondary. On June 21, 2007, the commission implemented a policy to reduce the secondary road system by:

- Seeking legislative changes to the system laws;
- Lowering county road caps when a secondary road is removed from the system¹;
- Exchanging roads with local governments; and
- Accepting only roads into the system that are necessary for interconnectivity of the state system or is a road considered a major collector with significant traffic volumes

• The secondary road cap for a county may be increased when a road meeting the above criteria is added to the system at the Department's request or when corrections to the existing road mileage is made and results in an increase in the total mileage above the cap.

¹County caps were previously implemented by the commission in 1994.

Rescind Action Adding Roads to State Highway Secondary System

The Department recommends the Commission rescind its previous actions adding roads to the State Highway Secondary System for construction and maintenance. The Department may rescind action on roads, which have not been constructed and formally accepted into the State Highway Secondary System. Roads may be rescinded due to right-of-way being unavailable, problems arising during construction, or funding issues.

Transfer between Secondary and Primary Systems

The Department recommends Commission approval to transfer sections of road from the Secondary System to the Primary System, or vice versa. Pursuant to the provisions of Section 57-5-50 of the Code-of-Laws of South Carolina, the Commission may transfer any route or section of route from the state highway secondary system to the state highway primary system, or vice versa, when, in its judgment, such transfer is advisable to better serve the traveling public. However, pursuant to the provisions of Section 57-5-30, the Primary System shall not exceed ten thousand centerline miles.
