
# S-250 (HESTER STORE ROAD) OVER MACHINE CREEK BRIDGE REPLACEMENT - PICKENS COUNTY, SC

# PROJECT OVERVIEW

The South Carolina Department of Transportation (SCDOT) is proposing to replace the bridge along Hester Store Road over Machine Creek in Pickens County. The purpose of the project is to replace the existing bridge to meet current design and safety standards. In effort to address immediate traffic concerns with the existing closure, SCDOT intends to demolish the existing bridge and install a temporary bridge. This allows time for the permanent replacement design to be completed while providing immediate relief to the traveling public. Once construction for the permanent bridge is approved, the temporary bridge would be replaced with a new two-lane bridge, and a detour will be re-established during this time.

Title VI Compliance

SCDOT complies with all nondiscrimination requirements set forth by the Federal regulations issued by the U.S. Department of Transportation under Title VI of the Civil Rights Act of 1964, as amended. Any person who believes that he or she has been discriminated against because of race, color, religion, sex, age, handicap or disability or national origin under a program receiving Federal Aid has the right to file a complaint with SCDOT. The complaint should be submitted no later than 180 days after the date of the alleged act of discrimination. It should outline as completely as possible the facts and circumstances of the incident; and should be signed by the person making the complaint.
